Response to letter to editor re: "Risks and contraindications of medical compression treatment - A critical reappraisal. An international consensus statement"

Dear Editor.

We read the letter of D. Rastel with great interest.¹ The aim of our consensus paper was to review the available literature, to undertake a critical appraisal of reported side effects, and to provide recommendations on contraindications and risks of MC treatment.² The literature review was mainly based on papers listed in PubMed. Unfortunately there are only very few published studies focusing on side effects of compression. The majority is published as case reports or in consensus documents. Some case reports which have been published in journals not listed in PubMed may have been missed in our literature search but in our opinion, this is not altering the message of our paper. The reason why we didn't include reports in the Medical Devices Vigilance System, available in several countries, is that these reports are published only occasionally in scientific journals³ and compression as the reason for reported adverse events is not always verified. Therefore, these reports alone may not be equal with a publication in a reviewed journal. As mentioned in the letter to the editor "the results of inquiries are sometimes published when these cases are worthy of being reported to the medical community". If this is the case these papers may also be found in a PubMed based literature search.
